Despite the fact that the material has been consumed in the work, yet our payment amounting to Rs. 118823/- has not been paid to us since one & half year. We have sent all these reminders and personal visits but our bill remain pending since then.

It is submitted that today we telephoned Mr. Gagan, Junior Engineer Incharge of the work and Executive Engineer. Yourself informed us on telephone that you are on tour to Amloh and Mr. Gagan, Junior Engineer be informed that he should meet you personally on Monday i.e 12.06.2017 to do the needful. Shri Gagan, Junior Engineer has accordingly been informed on telephone.

Now it is submitted that we are very old contractors dealing with your department since its inception. We had gone to the **Chief Executive Officer**, **PWSSB**, **Chandigarh** who had given us an appointment on 02.06.2017 regarding our various issues through our Association Northern India Tubewell Drillers Association. However the meeting could not take place as the Chief Executive Officer had to go to Delhi. The next meeting is due shortly.

It is submitted that we wish to avoid a unplea needs to be made to the highest authority which we want to avoid as far as possible.

As the matter is not being attended to for the last over one & half years therefore we shall have no other remedy in case our issue is not resolved immediately.
