Respected Sir/Madam,

My name is Umrinder Singh Chahal. I am an advocate practising at Sub-Divisional Judicial Courts, Budhlada. I am residing at Bus Stand Road, Budhlada district Mansa. My grievance is as under :-

That the drinking water supply to my house, street and the whole area comes from a more than 50 years old water supply pipe line made of iron. Now, this iron pipe line is not worth to supply clean water to the residents of the whole area as it is destroyed by the time and other circumstances. Because of bad condition of the main pipe line we the people of whole area are getting sevrage mix polluted water supply. We have requested a lot to the authorities to change the whole main pipe line, but all results in vain. We the people of whole area requesting you to make efforts to change the whole main water supply iron pipe to help us to access to clean drinking water.

We the people of whole area will be very thankful to you.

I am also attaching some important decisions of Hon'ble Courts in support of my request, where Hon'ble Supreme Court held that "the right to clean water is a fundamental right under Article 21 of the Indian Constitution."

If my request not entertained within 7 days, then consider my request as Legal Notice to all of you and i would have to approach Hon'ble Judiciary to redress my fundamental rights granted to by the Indian Constitution under Article 21.
